

## Sewer Rates

Effective with Bills Mailed on or After July 1, 2023

### Single Family Residential Customer

Residential sewer charges are evaluated each calendar year based on 60 days of the lowest daily water consumption documented during a full two-month back-to-back billing period in the previous calendar year.

<b>Base Sewer Fee</b>	\$41.12
<b>Sewer Rate (per HCF)</b>	\$4.16
<b>New Customer Fee: Base + Sewer Rate*</b>	\$70.24
<b>Maximum Fee: Base + Sewer Rate</b>	\$91.04

**Residential Sewer Charge Formula:** Average of the previous year's two consecutive bill periods lowest Units-Per-Day Avg (bill period units divided by number of bill days) x 30 Day Avg Bill x Strength Rate = Total Flow Charges. PLUS Base Charge (1 edu) = Total Fixed Monthly Service Charge.

\*The **New Customer Fee** is charged to single-family residential customers that have not established a full year of water-use history in their current place of residence. It is based on the average single-family residential usage of 7 HCF/month.

**Commercial/Industrial/Govt Sewer Charge Formula:** Water Consumption Units x Return To Sewer % x Strength Rate PLUS Base Charge x #EDU's per account.

The District uses the State of California guidelines as the basis for the concentration levels. The following list was created to categorize commercial accounts within the District's discharge area.

### Concentration Level 1 (0-400 mg/L)

Service Station, Retail, Car Wash, Beauty Shop, Health Services, Public Storage, Hospital, Convalescent Center, Coin Op. Laundry, Printing/Photo Co., Churches, Education Facilities, Utility Departments, Bar w/o Dining, Concrete Co., Electrical Manufacture, Veterinary Services, Retail Food Products, Convenience/Liquor Stores (no food service), Business Office, Department Store

### Concentration Level 2 (401-500 mg/L)

Hotels w/o Dining, Auto/Mechanical Repair, R.V. Park, Machine Shop, Service Station w/Mini Mart

### Concentration Level 3 (501-799 mg/L)

Shopping Center, Nurseries, Theater, Amusement Park, Commercial Laundry

### Concentration Level 4 (800-1000 mg/L)

Convenience/Liquor Stores w/ Deli, Lumber Yard, Furniture Manufacture, Textile Paper Mill, Rubber & Plastics Manufacturing, Dairy Products/Yogurt Parlor

### Concentration Level 5 (1001-1600 mg/L)

Hotel w/Dining, Industrial Laundry, Supermarket, Mortuary, Bars w/Dining

### Concentration Level 6 (1601-Up mg/L)

Meat Products, Restaurant, Auto Steam Cleaning, Bakery Products, Deli, Septage

## Return To Sewer Percentage

All accounts, other than single family residential, will be assigned a Return to Sewer (RTS) percentage. This percentage will indicate the estimated water returned to the sewer system for the type of service and user of the account. These percentages will be estimated by the District and used for billing purposes.
